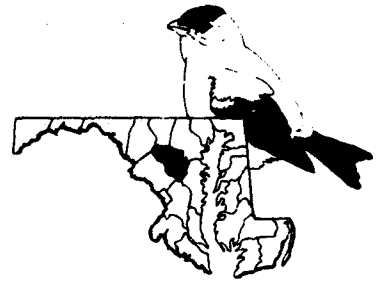

BIRDING "HOT SPOTS" IN HOWARD COUNTY - CHRIS LUDWIG - CYPRESSMEDE PARK

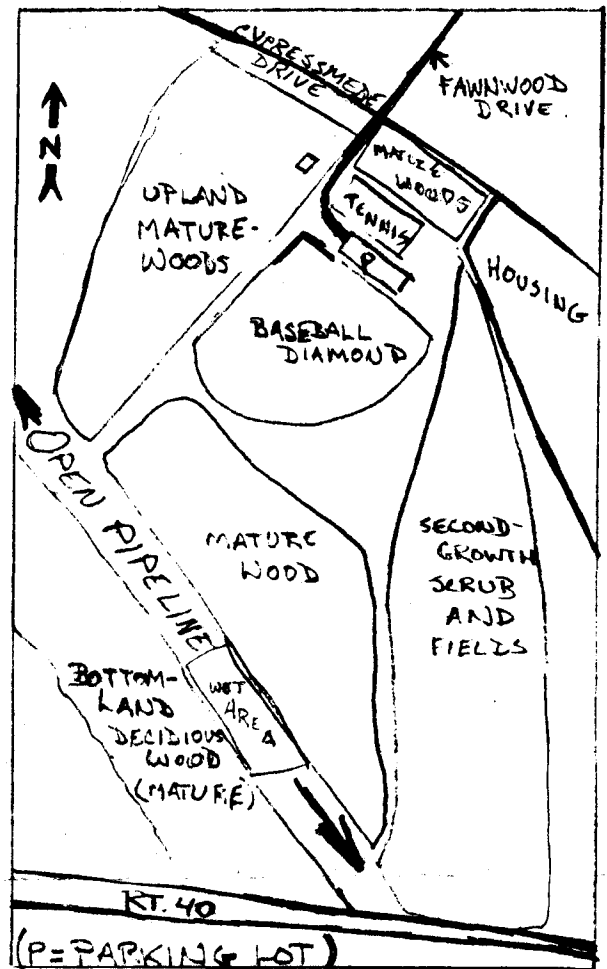
Cypressmede Park, one of Howard County's neighborhood parks, provides county naturalists with a variety of habitats that can be covered in an hour or two. To get to the park, turn right off Route 40 onto Greenway Drive, which is the entrance to Valley Mede, about 1 mile west of the junction of Routes 29 and 40. (No left turn is possible for eastbound traffic; if coming from the west, continue toward Chatham Mall until you are able to make a U turn.) After turning onto Greenway Drive, turn left almost immediately onto Longview Drive; continue to Cypressmede Drive where you again turn left. Turn left onto Fawnwood Drive; the park entrance is a short block ahead. If the gates are closed, park near the entrance and walk in. This 20 acre park is seldom crowded and most of the users tend to cluster around the tennis courts and baseball diamond. The area is criss-crossed with trails.

The diversity of habitats offers a diversity of bird species. The well-maintained residential and park areas are the haunts of House Finches, Northern Mockingbirds, House Wrens, and other "urban" birds. The second-growth scrub areas can yield Prairie Warblers, Northern Cardinals, Common Yellowthroats, and Yellow-breasted Chats. Bluebirds have been seen in some of the open areas.

The mature woods will offer some variety in woodland species such as woodpeckers, chickadees and titmice along with Wood Thrushes and Rufous-sided Towhees. Topping the list of interesting species is a Great Horned Owl, resident in the area, which was sighted in 1984 and 1985 (with young). A careful watch for these owls may prove fruitful for they are not easily found in Howard County. Other forest birds (though not necessarily breeding species) which have been observed include Hermit Thrush, Hairy Woodpecker, Rose-breasted Grosbeak and Scarlet Tanager. The diversity in habitat correlating with a change in the bird community makes Cypressmede an excellent locale for beginning birders to learn species' habitat preferences.

Another highlight of Cypressmede is its botanical diversity. The open pipeline in the southwestern portion of the park is an excellent area in which to find many of our common summer and autumn wildflowers. The wet area (see map) can be outstanding although it has diminished in size with the past few dry years. Howard County Recreation and Parks has spread their "wildflower" mix around the baseball field, parking areas and roadways so don't be fooled. They may be "wild" somewhere, but most are not indigenous to this county. Some of the local flowers you can find include Cardinal Flower, Rose Pink, Tall Blue Lettuce, Mistflower, Wild Potato Vine, Ditch Stonecrop, Water Plantain, Monkey Flower, Winged Monkey Flower and Flowering Spurge.

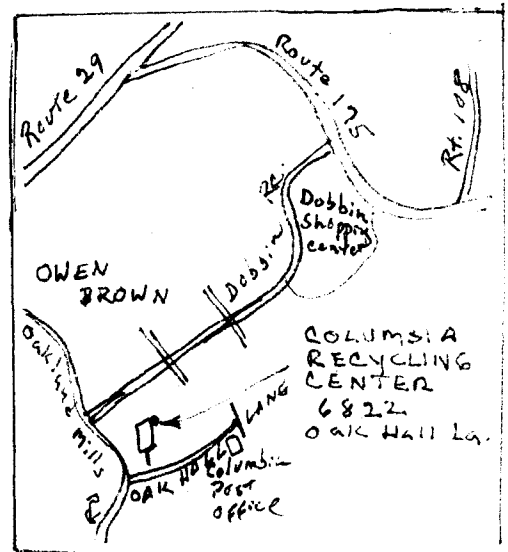
BOOST BLUEBIRDS (AND OTHER NATIVE CAVITY NESTERS) - BOB BOGDAN

Attached is the cavity nester survey form for 1986. Please complete it and return promptly. If you erected and monitored one or more bird boxes (and kept the House Sparrows from nesting), we would like to add your box(es) to the large Howard County map we now have showing the location of cavity nester boxes whose results are reported to us for compilation in the MOST (MD Ornithological Society Trails) Program. All new and renewing club members will receive a newly compiled "Boost Bluebirds" pamphlet which discusses aging nestlings, monitoring techniques, ways to control predators, nest identification, and more. If you want to help but do not have land or the right habitat, check the appropriate blank on the questionnaire and we'll try to help you adopt one or more boxes.

ATTENTION ALL RECYCLERS!

Beginning August 9 the Columbia Recycling Center will move its location to the Hamilton Avnet building (the first building on the left) on Oak Hall Lane not far from the Columbia post office and just a few blocks from their previous location. They will be in the back righthand corner. Because they are expanding their program to include more developmentally disabled clients they are asking that all individuals who recycle for organizations bring materials on SATURDAY ONLY between 9:00 a.m. and 1:00 p.m. when there will be staff only working.

They express their appreciation for our recycling efforts and hope these new hours "will not pose any real problems." Please continue to designate the Howard Co. Bird Club to receive credit when you recycle.



LENDING POLICY FOR MOUNTED BIRD SPECIMENS

A policy for lending the mounted specimens owned by the Howard County Bird Club was adopted by the Board of Directors on October 24, 1985. The statement will be supplied in its entirety when birds are borrowed. In summary, they require that borrowers assume responsibility for specimens, the club's educational and publicity needs have the highest priority, birds may be borrowed for one week by members for presentations or up to three may be borrowed for individual use for a maximum of one month. Non-member's requests are considered on an individual basis; specimens are not lent to non-members for personal use but only for educational presentations. Any display or presentation by non-members must contain a sign identifying the lenders.

NEWEST BIRD SPECIMENS NOW HAVE BOXES THANKS TO FRANK GRIFFIN

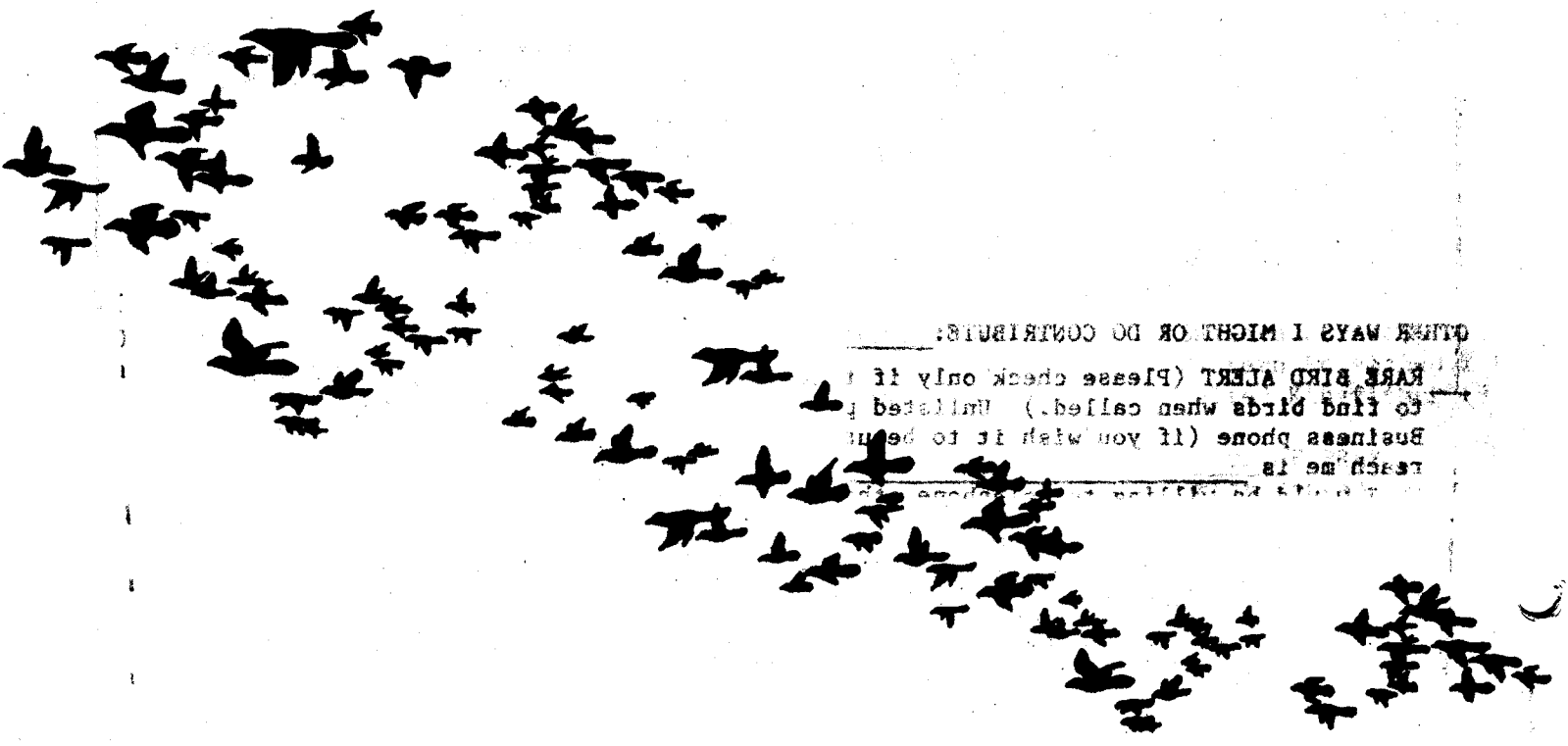
During the summer, Frank Griffin built three boxes for specimens so a few birds that we have had for some time can now be used. Within the last six months we obtained a Great Horned Owl, a Broad-winged Hawk, a female Northern Bobwhite and a male Rose-breasted Grosbeak courtesy of Greg Kearns, a naturalist at the Jug Bay Environmental Center. We are still searching for a taxidermist who can mount some of the small birds we have in the freezer. Suggestions are welcome. To help defray the cost of commercially mounting birds, Frank Griffin has generously donated five dozen well-crafted decoupage bird plaques in several sizes. He asked that they be sold at a very modest price so that they would move quickly. They will be available at upcoming meetings and seed sales. Check the club bookstore.
